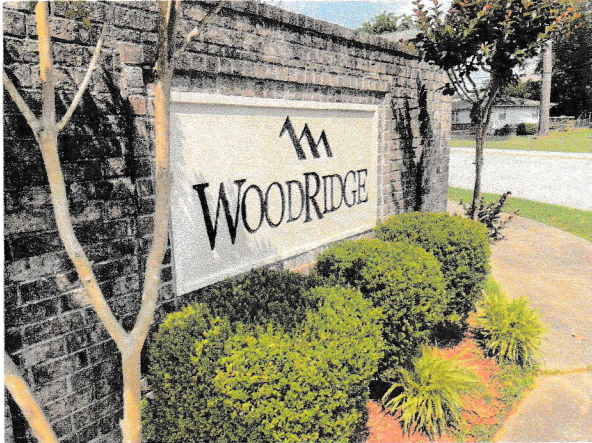

ROLL-OFF DUMPSTER MARCH 20 - 23, 2023

Location: Dodd Drive

Woodridge Association Officers will be providing an opportunity for our homeowners to dispose of their household items.

Starting Monday, March 20, there will be a large dumpster delivered on Dodd Drive for the residents of **Woodridge Neighborhood ONLY** to dispose of their unwanted household items. It will be available through Thursday, March 23.

We encourage residents to use these three days to dispose of household items, like mattresses, furniture, clothes, paper & plastic, trash, planters (not with plants or dirt), etc.

Please make sure that all items are placed **IN** the dumpster and **NOT BESIDE** the dumpster.

REMEMBER! NO YARD WASTE OR ELECTRICAL APPLIANCES ALLOWED. The following page contain a listing of prohibited items.

A penalty of \$250 plus tipping fee will be charged for any of the following prohibited materials placed in the roll-off container, so be a good neighbor and adhere to the rules so we can look at doing this again in the future.

Here are some general guidelines of items that are **NOT** allowed:

Temporary Dumpster

- Aerosol cans
- All liquids
- Animals
- Antifreeze
- Appliances
- Asbestos
- Barrels
- Batteries
- Chemical products
- Computers
- Construction & Demolition waste resulting from the construction, reconstruction, demolition, remodeling or repair of premises. This includes, but not limited to, rock, dirt, concrete, brick, asphalt, lumber and processed wood products, roofing, sheet rock, plaster, doors and windows.
- Contaminated oils (mixed with solvents, gasoline, etc.)
- Dirt
- Explosives of any kind, such as small arms ammunition, black powder, blasting agents, compressed gas cylinders or any kind of flammable materials.
- Fluorescent tubes
- Hazardous waste
- Herbicides and pesticides
- Industrial waste
- Lubricating/hydraulic oil
- Medical waste, infectious waste, sharps, needles, or lancets
- Microwaves
- Monitors
- Motor oil
- Oil filters
- Other flammable liquids
- Paint (except dried latex paint cans, no liquids)
- Petroleum-contaminated soil/lead paint chips
- Propane tanks
- Radioactive material
- Railroad ties
- Solvents
- Televisions
- Tires and vehicle parts
- Transmission oil
- Yard Waste
